

- The MSRT was founded in 1931 and is one of the oldest affiliate societies in the U.S.
- The MSRT has had as many as 2200 members during the early 1990's.
- The MSRT has been declining in membership and is now under 700.

MSRT Membership Benefits

Advocacy:

- MSRT has been a consistent leader among all states in advocating for our professions. The implementation of State Licensure in 1989 was due to the commitment of MSRT board members.
- The MSRT represents every technologist in Massachusetts. Board members visit Beacon Hill to address legislative bills that have the potential to affect the radiology profession, the patients in our care, your job and every technologist in Massachusetts.
- The MSRT has submitted testimony on Beacon Hill against the encroachment of Physician Assistants, Certified Nurse Practitioners and Podiatry Assistants into our profession.
- When federal bills are introduced that include licensure or scope of practice parameters for medical imaging or radiation therapy professionals, the MSRT carefully reviews the language to determine if it is in the best interest of Radiologic Technologists in Massachusetts and patient care.
- The MSRT also serves as a resource for governmental agencies seeking information about medical imaging and radiation therapy.
- The MSRT speaks on behalf of the medical imaging community at hearings, briefings and on task forces and committees.
- A team of MSRT board members and other imaging professionals collaborated with the Radiation Control Program (RCP) Director, to revise the Massachusetts Radiology Licensing Regulations. These regulations are now being reviewed on Beacon Hill and will soon become the new standard in Massachusetts.
- We are also working on reactivating the Massachusetts Advisory Commission to assist in the implementation of our license bill.

National Representation:

- The MSRT is assigned two (2) seats in the ASRT's House of Delegates (HOD) meeting where the national practice standards and position statements in the radiologic sciences are revised, updated and voted on. These are the very statements and standards that technologists abide by in our daily work caring for patients, while obtaining optimal medical images using the ALARA principle.
- The MSRT was recognized this year (2016) by the ASRT at the annual HOD meeting for our outstanding efforts and accomplishment in Grassroots Advocacy.

CE Credits:

- In 2016-2017, MSRT members can earn eight (8) continuing education credits free of charge by attending two (2) half day educational seminars. One (1) CE credit in radiation safety will be provided at each seminar along with interesting lectures on current topics pertinent to today's technologist. - In addition, all MSRT members get discounted admission this year to a Mammography Seminar for \$30, where you will earn four (4) Cat A/DR/M credits. Please go to our website for additional information (www.member.msrt-ma.org).
