assachusetts Radiologic Technologist Licensing regulations now recognize Radiologist Assistants (RA) and Nuclear Medicine Advanced Associates (NMAA). Please take a few minutes to support the RAs by contacting your federal legislators and asking them to co-sponsor the current bills to obtain Medicare recognition.

It's easy to do, just follow the link below to submit a pre-formatted message and tell your legislators that radiologist assistants play a very valuable role in health care and should be recognized by Medicare. It is up to us to convince our senators and representatives to support these bills. As a direct result of Medicare's current policy RAs are losing their jobs and universities are on the verge of suspending or terminating their radiologist assistant programs. Without Medicare's recognition of RAs, the profession is in peril.
